ALL SHOW ENTRIES DUE BY DECEMBER 4th, any entries after this date will have a \$20.00 late fee added. THERE WILL BE NO ENTRIES AT THE SHOW, last day for late entries will be DECEMBER 11th, 2024

**Market Pigs must be tagged with a clean and readable ear tag before check in.
840 tags do not meet this requirement.**

1. Any GEORGIA exhibitor 21 or under is eligible to show. *Open to Pre-Club, 4-H and FFA Exhibitors*)....*there will not be a showmanship for exhibitors over 12th grade*
2. All swine must have an official health certificate.
3. Market barrows and market gilts will be shown separately by weight. Purebred gilts with registration certificates will be shown by breed and by age. Purebred barrows will be shown by weight and go back to compete with market barrows for overall barrow. Commercial Gilts by weight, must weigh under 280 pounds.
4. The barn will open at 3:00 p.m. on December 13th , 2024. All market hogs and purebred barrows must be weighed and registered gilts must be checked in by 7:00 p.m. that same day. THIS IS NOT A WEIGH BACK SHOW !!!
5. Prize money will be paid to the top 10 in each class. Contingent on number of entries and sponsors if funds permit.
6. All entries must be submitted online by December 5th, 2024. The entry fee is **\$35.00** per pig. A **late fee of \$20.00** per head will be required after this date. The committee reserves the right to refund money to entries if the number of entries exceeds pen space. All entries can be processed online. Entry fees cannot be switched from one exhibitor to another. The late fee will be strictly enforced. No refunds on entry fees. No entries permitted after December 11th, 2024.
7. Market Hog Show: Barrows and gilts will show separately. Divisions if needed in the barrow and gilt market hog shows will be divided evenly among the classes, as evenly as possible. All purebred barrows must be registered with a proper registration certificate from the National Swine Registry. If there are not

enough entries for a purebred division, they will show as crossbred market barrows. Division winners will compete for Champion honors. Market gilts may not double enter as Commercial Gilts.

8. Registered Breeding Gilt Show: All gilts must be registered with a proper registration certificate from the National Swine Registry for their respective breed. Purebred entries must show the exhibitor's name or exhibitor's family farm as the current owner on the registration paper. Registered breeding gilts do not have to have ear tags but must be ear notched according to their registration certificate. Entries must be farrowed in June, July, August, or September 2024. A minimum of 7 head will be required to hold a breed show. If there are less than 7 head of a breed, they will be shown as All Other Breeds. Breed Champions and Reserve Champions will be chosen for each breed. A Supreme Overall Champion and Reserve Supreme Champion Breeding Gilt will be chosen. **Breeds recognized if enough**, Berkshires, Duroc, Hampshires, Yorkshire and all others will be A.O.B. Commercial Gilts will have to be weighed in and must weigh under 280 pounds. Commercial Gilts may not Double Enter as Market Gilts.

9. The pen fee is **\$10.00** per pen. If you have special penning request please email Teri Tankersley at ttankersley@madison.k12.ga.us

10. Showing from the trailer will be permitted. A fee of **\$40.00** will be charged. They are outside with no cover overhead. Limited number of spaces, (approximately 20). **Tents are permitted over the rear of your trailer for shade or rain, but all personal items like coolers, chairs, tables need to be set up in the tongue area of your space. Please do not have items behind your trailer, pigs can't pass through to get to the show ring.**

11. Showmanship will begin at 9:00am on Saturday December 14th, 2024. Exhibitors must pay a **\$15.00** entry fee for showmanship. Classes will be broken down by the exhibitors' grade level. Showmanship will be shown from the youngest to oldest and broken into heats according to the number of entries. Belt Buckles to Champion for each class and cash payouts through top 10.

The rules committee reserves the right to interpret all rules. Decision of the judge and the rules committee will be final.

No alcoholic beverages permitted on show grounds! Smoking, dipping, chewing, or spitting allowed there is a designated smoking area located outside the facility. Children must be supervised at all times. There is no "horseplay" type of behavior permitted in the facility.
